I was given two months to live

- a year later, I'm cancer-free

URTHER to the recent letter in the Guernsey Press by a lady who has had a successful result using GcMAF, I would like to add my own endorsement of this treatment due to my remarkable 'recovery' from grade four metastasised cancer to the liver.
